
Cared for **76%** of MSSP patients




NAACOS Members are REACH ACO Savings and Quality Leaders in 2023





NAACOS Members are Chronic Care Management Leaders in 2024






MSSP ACOs with <5% uncontrolled diabetes & controlled hypertension >85%
